1 Introduction

An HRMS (Human Resource Management System) is a type of HR software that enables the management of several HR functions through the use of information technology. An HRMS aims to improve the productivity and efficiency of the business through the automation of manual and repetitive tasks. This, in turn, also frees up the time which can then be used to address more strategic, business-critical tasks. This document is intent to contain the working and usability descriptions related to the Employee Self Service processes identified and documented in System Requirement Specification document in the form of a user manual.

1.1 Objective

The following objectives shall be fulfilled with the user manual

- Serve as a standard document for FCI employees to gain experience in adopting the HRMS
- Provide comprehensive details about working on different Employee Self Service processes and managing exceptions and alerts as per different processes.
- Reveal the user experience for working with the HRMS and act as a reference for users to reinforce working tactics with the HRMS as per requirement.

1.2 Target Audience

• FCI Officers and FCI Employees

2 Overview

The Employee Self Service (ESS) will serve as employee service portal allowing foremost collaboration among FCI employees to initiate, track and monitor various service requests. ESS shall serve as one stop workspace for intercommunication of various other process areas in HRMS, providing an impression of seamless business transaction management with high degree of usability to FCI employees.

3.1 Set Up Consideration

3.3 User Access and Permissions

HRMS user access and permissions is managed by a specialized workflow management system that is further supplemented with roles and permissions. The User Management Process has been coined as the centralized access manager where employees are provided various roles and permissions to access different set of features. Table 3-2 showcases the permission and user access provisions in general to HRMS Processes.

Table 3-3 defines the provision of different roles assigned as per the permissible architecture of HRMS application. A user role basically describes the user access of what the user can navigate around in the HRMS application. The user permissions as described in Table 3-2 combines with user roles to allow the user to "navigate" and "perform" the nature of processes as per the delegated power.

3.4 Accessing the system / System Organization and Navigation (Login, ESS and MSS)

 User shall access the HRMS application as per the shared website address (https://www.hrmsfci.in/login) and provide the credentials in the form Login ID (Employee Number) and Password as shared by FCI Computer/IT section as shown in Figure 3-1.

3.5 Exiting the System

When the employee would like to exit from the HRMS application, then employee shall click on $^{Sign Out}$ to log out of the system as shown in Figure 3-3

- The user shall navigate to Login Page as shown in Figure 3-1 on successful log out.
- An employee shall automatically logout from the application if it remains idle due to inactivity for a longer period of time (approx. 1 Hour)

3.6 HRMS Login Configuration

HRMS Login are handled using OAuth 2.0 protocol. The user credentials entered by user is passed on internet to HRMS System for validation and after successful validation a token is generated and shared to the application to use it at the time of every new server interaction to validate the user credentials. The login activity has few timeout settings as illustrated below.

- Access token Lifespan This is the setting for capturing the lifespan of Access token before it gets expired. Before access token gets expired a refresh process is triggered to get the new access token to keep the session alive until user logout of the session. Default is set to 1 hour.
- **SSO Session Idle** These is the setting for time a user session can be idle before it gets expired. Default is set to 1 hour.



These are timeout settings done at Key cloak IAM interface.

4 Using the System

The Employee Self Service (ESS) will serve as employee service portal allowing foremost collaboration among FCI employees to initiate, track and monitor various service requests. ESS shall serve as one stop workspace for intercommunication of various other process areas in HRMS, providing an impression of seamless business transaction management with high degree of usability to FCI employees.

4.1 Employee Dashboard

Dashboards shall serve as a common workspace to track and carry out approval actions. FCI employees can access the Dashboard after login. It shows the employee's planned leaves and Holidays, attendance, Trainings, etc. records in a glance. Based on the user credentials and permissions assigned to the employee, an employee shall be able to access the Employee Self Service by clicking the **Dashboard** link as shown in Figure 3-2 to land on the ESS – Employee Dashboard as shown in Figure 3-3.

4.2 Manager Dashboard

Dashboards shall serve as a common workspace to track and carry out approval actions. After login, FCI managers can access the Dashboard based on access rights. It shows the pending requests to be approved by Manager, Team Attendance, Trainings, etc. records in a glance. If an employee has been assigned the roles and responsibilities of a manager or competent authority, then by clicking the **MSS** link on the top right corner of the HRMS application as shown in Figure 4-1, the employee with the permissions of a manager shall navigate to the MSS – Manager Dashboard as shown in Figure 4-2.

4.3 Directory

Directory shall allow an employee to view the organization chart and fetch the job description, and career path of an employee based on the designation. The following features are included in the scope of the Directory:

- Employee Hierarchy- Employee can view employee details such as Name, Email, Designation, Division, Location and Employee Number.
- Organizational Hierarchy- Employee can view organization chart of complete FCI

- 2. Selecting the Office Type, Zone, Region, Office, Division and clicking on Get Details button.

4.4 Retirement Benefit Calculator

Retirement Benefit Calculator shall showcase the retirement benefits to employees with an active employment status to reflect the changing gratuity and leave encashment based on current date.

The following features are included in the scope of the Retirement Benefit Calculator:

- Employee shall be able to see the retirement benefits based on current date.
- Employee salary and leave details shall be fetched automatically and processed by the system as per the business rules governed by gratuity scheme for government employees.

4.5 Connect+

Connect+ will allow employees to search and initiate conversations with respective employees of interest and shall serve as a provision for open communication within the HRMS application. Employee shall be able to search an employee across any office and initiate conversation. The system shall be capable to identify each conversation uniquely based on Message ID. The subject line shall be permanently stored as a record against which new conversations related to the subject will be initiated with any other FCI employee(s).

5 Troubleshooting and Support

5.1.1 Error Messages

In reference to standard error messages that may appear in the application with respect to user and internet settings, the following status codes may reflect:

13	403 Forbidden	Access is forbidden to the requested page.
14	404 Not Found	The server cannot find the requested page.
